

Backstretch:

Call to trainer Luthia Shirley, entered the horse, Brixton Hill, 1st race September 2, 2018, ineligible, on the Veterinarians' list, necessitating a scratch.

Trainer Luthia Shirley attended signed Notice of Review, had horse a week, did not know horse was on Vet's list, race office never informed her of ineligibility upon making entry.

Spoke with Entry Clerk, R. Gawel, entry system did not reveal the horse was on the list. It was determined that there were extenuating circumstances and Ms. Shirley informed no action be taken with regards to the entry.

Race 6, #6 Case in Point bore in at start to #5 Call Me Gizmo, #5 Call Me Gizmo was eased through the stretch. Rest ok

Race 7, #1 Savoia a late Stewards scratch as it entered the track for post parade, unseated jockey S. Singh, ran off to the $\frac{1}{4}$ pole and exited the track. S. Singh appeared uninjured but requested to be excused from his mount in the 8^{th} race.

#2 Coddiwomple popped up at start, #3 Themis broke a step slow and eased into the stretch and did not finish.

Jockey claim of foul, #5 Delly, J. Crawford, 3rd on #2 Coddiwomple, K. Johnson, 2nd around the far turn. Upon review of back tower and apex camera angles, #2 is outside of #5 rounding the turn, appears to leave room for the #5 as he passes, J. Crawford checks slightly. Jockey claim of foul disallowed.
